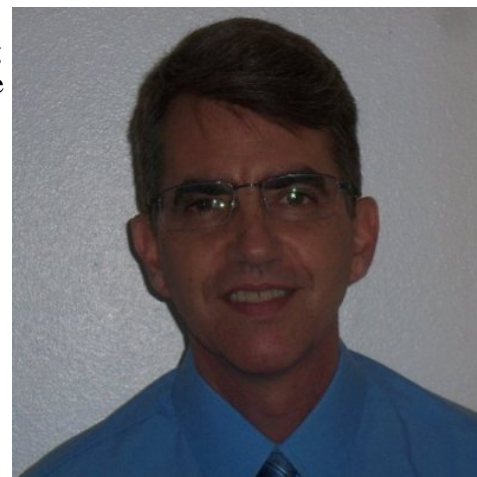

Brian Freeborough – P.E.T.S. Coordinator

Brian Freeborough comes to BEi with 36 years of experience working with people with differing abilities. He originates from Pittsfield, PA where he was born and raised.

After graduating from Edinboro University in 1980 he moved to Omaha, NE where he worked for the Eastern Nebraska Human Services Agency.

He moved to Phoenix, AZ in 2002 where he worked for The Tugland Corporation and Peckham Inc. Brian returned to Pittsfield in 2014 and began working as a Building Aide within the Warren County School District (WCSD) prior to being hired as the new BEi Pre-Employment Transition Services Coordinator .



The first P.E.T.S. classes began on December 12, 2016. BEi is working in coordination with the Office of Vocational Rehabilitation and WCSD to present weekly classes for eligible students in the areas of Independent Living Skills, Self-Advocacy and Workplace Readiness Training as defined by Workforce Innovation Opportunities Act (WIOA). Students involved in the program range in ages 14 through 21 years old. The P.E.T.S. Coordinator travels to 6 schools throughout the WCSD conducting 20 classes per week. Classes will continue after the holiday break until the end of the school year.

Jeanine Valencia—ATF Program Specialist



Jeanine Valencia began working in the human services field in 2004, providing support services for adults with intellectual and developmental disabilities. She has worked with multiple individuals in Warren County, and has become familiar with the difficulties, triumphs, and needs within this population. Jeanine has a BA in Psychology from Pennsylvania State University, which she earned while being home fulltime with her children. In October 2015 Jeanine returned to work as a Direct Care Staff in the Adult Training Facility (ATF) program at BEi. Surrounded by individuals she had provided services to over the years combined with her years of experience, stepping into the position of Program Specialist

made sense.

Jeanine's vision for the ATF program is to offer our individuals the opportunity to build confidence and independence through the development of life skills, to be active in therapeutic activities such as music and art, and to develop relationships in the community through volunteering.

ATF Volunteering



One component of the ATF program at BEi is to provide our individuals with opportunities to volunteer in the community. Volunteering helps our individuals improve social skills, feel good about themselves, and to develop relationships in the community. In addition to socializing cats at Paws Along the River, individuals have been volunteering at St. Francis Episcopal Church in Youngsville, Audubon Community Center in Jamestown, and New Hope Assistance Dogs in Starbrick. During the holiday season, individuals rang the bell for the Salvation Army. Going into the New Year, we will be making new connections in order to provide our individuals additional volunteer opportunities.

Message from BEi Executive Director

Dear Friends:

I am excited to be a part of BEi. After six months on the job, I quickly recognized the many outstanding qualities of the individuals and employees at BEi. I can only hope my skills and background can allow BEi to grow in a similar manner that it blossomed under Bob Klebacha's leadership.

The landscape is changing by forces beyond the walls of BEi. During the past year, Governor Wolf issued an Executive Order designating Pennsylvania as an Employment First state and the Workforce Innovation Opportunities Act (WIOA) replaced the Workforce Investment Act of 1973.

Executive Order 2016-03 outlines the governor's goal of increasing competitive integrated employment for Pennsylvanians with a disability. The policy reflects the Commonwealth's goal of making Pennsylvania a model state by creating a climate hospitable to workers with a disability.

WIOA will allow for a phase in of the standards imposed under the Act. WIOA outlines that by January 1, 2018 individuals will have 25% of their time in competitive integrated employment plus time in community locations and hubs. The percentage moves to 50% in July 2018 and 75% in January 2019.

As we all wind down from the holidays and look forward to 2017, I can say these are exciting times at BEi. As these new regulations unfold and impact BEi, my position is to make sure BEi stays true to its mission which is To Enrich the Lives of People with Disabilities.
